RESOLUTION NO: 2024-138

AUTHORIZING HEARING UNDER SECTION 6.7(b) OF SAULT TRIBE INC. CHARTER

WHEREAS, the Sault Tribe of Chippewa Indians ("Tribe") is a federally recognized Indian Tribe organized under the Indian Reorganization Act of 1934, as amended; and

WHEREAS, the Tribe wholly owns Sault Tribe Inc. ("STI"), a Federally Charted Section 17 Corporation; and

WHEREAS, the Tribe approved Resolution 2024-106 on April 2, 2024 authorizing a Complaint under Section 6.7(b) of the Sault Tribe Inc. Charter; and

WHEREAS, the complaint authorized in Resolution 2024-106 was served on the four remaining STI Board members on May 9, 2024; and

WHEREAS, the STI Board has seven days under the Charter to issue a written response to the Complaint authorized by the Tribe; and

WHEREAS, the STI Board response to the Complaint is due by noon on May 16, 2024; and

WHEREAS, under the Charter a hearing on a removal under Section 6.7(b) must take place no later than fourteen calendar days after the delivery of the Complaint.

NOW, THEREFORE, BE IT RESOLVED, that the Board of Directors for the Sault Ste. Marie Tribe of Chippewa Indians hereby sets a hearing on the removal of STI Board for May 20, 2024 at 9 a.m. in the Whitefish Point Room.

BE IT FINALLY RESOLVED, that the Board of Directors for the Sault Ste. Marie Tribe of Chippewa Indians hereby will release the letter from the BIA date stamped April 30, 2010 along with the Sault Tribe's response to that letter.
