COMPENSATION OF APPELLATE COURT JUDGES

WHEREAS, the Sault Ste. Marie Tribe of Chippewa Indians is a federally recognized Indian Tribe organized under the Indian Reorganization Act of 1934, as amended; and

WHEREAS, the Sault Ste. Marie Tribe of Chippewa Indians enacted Tribe Code Chapter 82, Appeals, which states in Section 82.103, Judges of Court of Appeals, that the Court shall be comprised of "[f]ive (5) judges, appointed by the Board of Directors" and further provides that "[a]ny number of judges may be appointed as reserve judges, who shall be available to serve on the Court of Appeals to hear a particular appeal for which an appellate judge is disqualified or otherwise unable to sit"; and

WHEREAS, Resolution 2005-114 provided compensation for attorney Judges at the rate of \$150/hour, capped (\$7500 Chief, \$5000 attorneys) annually for their billable professional time, plus a \$200/month stipend. And, Resolution 2024-34 increased the Chief Judge's compensation cap from \$7500/year to \$15,000/year and only increased reserve Judge DeMoore's compensation from \$4500/year to \$10,000/year. This resolution did not include increases to all attorney judges; and

WHEREAS, the number and complexity of appeals cannot be predicted in any given calendar year and under the existing compensation contract system, appellate judges are not being reimbursed for their actual time spent on appeals; and

WHEREAS, the Board has determined that it is in the best interests of the Tribe and its' Court systems to modify the compensation to contract with attorney judges at the rate of \$150/hour without a cap, plus travel time reimbursed at the GSA rate.

NOW THEREFORE BE IT RESOLVED, that the compensation structure for appellate attorney judges previously authorized by the Board of Directors in resolutions 2005-114 and 2024-34 is hereby modified to authorize contracting with all attorney judges at the rate of \$150/hour with no cap, plus travel expenses at the GSA rate and shall here on after exclude monthly stipends to the attorney judges only, beginning immediately.

BE IT FURTHER RESOLVED, that the Board of Directors hereby authorizes a FY2024 administrative budget modification to cost center 2781 for an additional \$31,500 with funding coming from unrestricted BIA funds.

WHEREAS, the complexity of the cases before the Court of Appeals has, more often than not, required law-trained appellate court judges to apply the laws of the Tribe and communicate the opinion and order of the Court of Appeals; and

WHEREAS, the Board has determined that it is in the best interests of the Tribe to formally set the composition of the Court of Appeals.

NOW, THEREFORE, BE IT RESOLVED, that the Judges of Court of Appeals, shall be comprised of three (3) law-trained judges and, in an advisory capacity, one (1) community member and one (1) elder for a total panel of five (5) seated judges.

FY 2024 INDIAN HOUSING BLOCK GRANT PROGRAM-COMPETITIVE GRANT (IHBG-C) APPLICATION

WHEREAS, the Department of Housing and Urban Development (HUD) has solicited a funding opportunity (FR-6800-N-48) for the Indian Housing Block Grant Program – Competitive Grants (IHBG-C); and

WHEREAS, the purpose of the Indian Housing Block Grant Program – Competitive Grants (IHBG-C), is the development of viable Indian and Alaska Native communities, including the creation of decent housing, suitable living environments, and economic opportunities primarily for persons with low and moderate incomes; and

WHEREAS, the competitive funding will provide the remaining utility infrastructure to facilitate future housing and construct housing units for single individuals, rental units that are low to moderate income tribal families on the Odenaang housing site; and

WHEREAS, the Housing Authority is seeking approval to apply for an award of up to \$7,500,000 of IHBG-C funds.

WAIVER OF SOVEREIGN IMMUNITY AND CONSENT TO WAIVER OF TRIBAL COURT JURISDICTION FRANCIS ENERGY

BE IT RESOLVED, by the Board of Directors of the Sault Ste. Marie Tribe of Chippewa Indians, as follows:

Section 1 FINDINGS AND DETERMINATIONS:

The Board of Directors finds and determines that:

- 1.1 The Sault Ste. Marie Tribe of Chippewa Indians ("Tribe") is a federally recognized Indian Tribal Government organized under the provisions of the Indian Reorganization Act of 1934.
- 1.2 The Tribe wishes to enter into Letter of Intent ("LOI") with Francis Energy ("Francis") as negotiated by Executive Director of Enterprise Operations to apply for Electric Vehicle Charging Stations; and
- 1.3 Francis will not consent to such LOI without a waiver of sovereign immunity or Tribal Court jurisdiction; and
- 1.4 In order to induce Francis to enter into an LOI, the Tribe is required to confirm that the Tribe and all other entities claiming by, through or under the Tribe will not claim sovereign immunity or exclusive Tribal Court jurisdiction with respect to any disputes or causes of action between the Tribe and Francis that might arise from, or relate to, in any respect, the LOI, or object to the venue clauses found in the Agreement. All the foregoing are referred to herein as the "Waiver and Consent Obligations"; and
- 1.5 It is in the Tribe's interest to resolve as stated herein.

Section 2 WAIVER OF SOVEREIGN IMMUNITY; CONSENT TO JURISDICTION; GOVERNING LAW

2.1 The Tribe hereby waives its sovereign immunity from suit in favor of Francis only should an action be commenced under the LOI referenced above.

This waiver:

Shall terminate upon performance by the Tribe of all of its obligations under the LOI; and

Is granted solely to Francis; and

Shall extend to inter alia, any judicial or non-judicial action, including, but not limited to, any lawsuit, arbitration, and judicial or non-judicial action to resolve disputes between the Tribe and Francis and the assertion of any claim in a court of competent jurisdiction or with any arbitrator or arbitration panel to enforce the obligations under the LOI; and

Shall be enforceable only in a court of competent jurisdiction, including courts in the State of Oklahoma, the Tribal Court and federal courts in Oklahoma (including the United States Bankruptcy Court or any arbitrator or arbitration pane); and

Shall be enforceable against the assets of the Tribe to the extent necessary to satisfy the Tribe's obligation in the LOI; and

The Agreement, and other associated documents shall be construed in accordance with and governed by all applicable laws and regulations of governmental bodies with competent jurisdiction, as set forth in such documents.

Section 3. WAIVER OF TRIBAL COURT JURISDICTION

3.1 The Board of Directors waiver the exclusive jurisdiction of the Tribal Court over any action arising under the Agreement. The Board authorized the Tribe to consent to the jurisdiction of any courts with competent jurisdiction, including any courts to which decisions may be appealed, with respect to any controversies arising from this resolution or any of the finance documents, note or Agreement.

Section 4. EFFECTIVE DATE

4.1 This waiver shall become effective upon the final execution of the Agreement executed by the Chairman or his designee. Failure or refusal of any individual to execute the Agreement shall render the waivers and consents granted in this resolution to become void immediately. Failure or refusal to execute the Agreement prior to the close of business on December 31, 2024, shall render the waivers and consents granted in this resolution to become void immediately.

Section 5. AUTHORIZATION

5.1 T The Chairman is authorized to execute any and all documents to effectuate the forgoing.
