# APPROVAL TO CONSTRUCT SEPTIC LAGOON ON TRIBAL LAND AT THE BARBEAU FISH HATCHERY

WHEREAS, the Sault Ste. Marie Tribe of Chippewa Indians (Tribe) administers a biological fisheries program, the Inter-tribal Fisheries and Assessment Program (ITFAP), which operates a walleye culture and stocking activity; and

WHEREAS, the Tribe owns a fish hatchery and fish culture ponds on 360 acres located at 15464 S. Shunk Road near Barbeau, Michigan; and

WHEREAS, the Tribe received funding (\$15,000) in 2011 pursuant to BIA's Hatchery Maintenance Program to install a septic system and bathroom facility at the Barbeau Hatchery; and

WHEREAS, a lagoon system would be much less expensive than a "mound" septic system, and the Chippewa County Health Department (CCHD) has determined that a lagoon system would be allowable at this location; and

WHEREAS, installation of a lagoon requires that the property deed be modified in a manner that would prohibit future division of the property in the immediate area of the lagoon (i.e. minimum of 10 acres), and prohibit the establishment of a dwelling within 200 feet from the lagoon (see attached affidavit from CCHD); and

WHEREAS, such deed restrictions will not impact current fish culture operations, or foreseeable development of the property within the restricted portion.

## URGING IMPLEMENTATION OF A SINGLE DEFINITION FOR THE TERM "INDIAN" UNDER THE PATIENT PROTECTION AND AFFORDABLE CARE ACT

WHEREAS, the Patient Protection and Affordable Care Act (Affordable Care Act) (Public law 111-148) was enacted on March 23, 2010; and

WHEREAS, the Affordable Care Act contains many favorable procedural rules, costsharing protections and mandatory enrollment exemptions specific to individual American Indians/Alaska Natives, referred to generally as "Indian"; and

WHEREAS, the references to "Indian" in the Affordable Care Act is not uniformly defined or lacks a reference to a definition of "Indian"; and

WHEREAS, the NIHB Medicaid and Medicare Policy Committee (MMPC) drafted a position paper titled "The Definition of Indian" under the Affordable Care Act on the issues regarding the definitions of Indian; and

WHEREAS, in the MMPC paper, the recommendation was made that the definition of Indian, adopted by the Centers of Medicare and Medicaid Services (CMS) that is found at 42 C.F.R. Section 447.50 and is consistent with the Indian Health Services (IHS) regulations on eligibility for IHS services, should be adopted uniformly in implementing the Affordable Care Act, including for the Exchange Plans, Medicaid Expansion, and the specific AI/AN provisions; and

WHEREAS, this Board of Directors wishes to express its approval of this proposed definition.

THEREFORE BE IT RESOLVED, in order to ensure to avoid confusion in the implementation of the Affordable Care Act and to ensure that AI/ANs receive the benefits and special protection intended for them in the law, one definition of "Indian" must be utilized; and

BE IT FURTHER RESOLVED, that the definition of Indian that was adopted by the Centers of Medicaid and Medicare Services in its implementation of the Medicaid cost sharing protections, found at 42 C.F.R 447.50 should be adopted uniformly in implementing the Affordable Care Act.
