WHEREAS, the Tribe has secured funding from the Michigan Economic Development Corporation (MEDC) and Fishermen's Fund for the Grand Marais Dock project; and

WHEREAS, bids were solicited for this project, and MCM Marine, Inc. has been determined to be the lowest bidder and qualified to conduct the work.


