Economic Development Commission WHEREAS, the Sault Ste. Marie Tribe of Chippewa Indians conducts a treaty commercial fishery upon the ceded waters of the Great Lakes pursuant to the 2000 Consent Decree; and

WHEREAS, MM 1-2-3 is a fishery management unit comprising northern Lake Michigan; and

WHEREAS, the fishery harvests lake trout in MM 1-2-3 subject to a lake trout harvest limit and for the 2015 season there is a concern that the fishery may exceed the lake trout harvest limit and incur a penalty which would result in a reduced lake trout harvest limit for the 2016 season; and

WHEREAS, the fishery monitors its harvest through a monthly catch reporting system that is codified in the Chippewa Ottawa Resource Authority fishing regulations; and

WHEREAS, the Great Lakes Conservation Committee believes it is in the fishery's best interest to install a twice a month catch reporting system, being stricter than that required by Chippewa Ottawa Resource Authority fishing regulations, upon the Tribe's fishers operating in MM 1-2-3 so that the fishery has a more up to date understanding of how many pounds of lake trout have been harvested at any given time; and

WHEREAS, the twice a month catch reporting system will not be imposed on trap net fishermen fishing in MM 1-2-3 because they are prohibited from retaining lake trout; and

WHEREAS, the amendment herein is considered temporary in nature as the Chippewa Ottawa Resource Authority will at a future date impose a similar twice a month catch reporting system upon the entire 1836 treaty commercial fishery; and

WHEREAS, the Great Lakes Conservation Committee has approved an amendment to Tribal Code Chapter 20: Great Lakes and St. Mary's River Treaty Fishing Regulations and requests the Board of Directors to amend said Chapter.

NOW, THEREFORE, BE IT RESOLVED, that the Board of Directors amends Tribal Code Chapter 20: Great Lakes and St. Mary's River Treaty Fishing Regulations by adding a new section which shall read:

#### 20.102(14) Bi-Monthly Catch Reporting for MM 1-2-3 (Temporary Regulation)

(a) Each Captain who fishes gill nets in MM 1-2-3 at any given time in any given season must submit to I.T.F.A.P. two accurate reports of their harvest for each approximate two week period within a given month.

- The first report shall be due the 10<sup>th</sup> of each month and the second shall be due the 25<sup>th</sup> of the same month.
- This section shall not apply to Captains fishing trap nets or to Captains who hold (c) a conversion license.
- C.O.R.A. fishing regulations at Section XIX shall remain in effect except where (d) stricter provisions are found herein.
